- Suitable for colourfast carpets & upholstery.
- Ideal for use in soft or hard water areas.
- Recommended for pre-spray treatment of badly soiled carpets prior to shampooing.

PRE-SPRAY TREATMENT:

Dilute 1:10 parts hot water (50 ml per 500 ml / 2 x  per 600 ml) in a spray bottle. Spray heavily soiled areas & traffic lanes prior to shampooing.

GENERAL SOILING:

Dilute 1:60 parts hot water (80 ml per 5 L / 3 x  per 5 L). For excessive soiling increase dilution to 120 ml per 5 L / 4 x  per 5 L).

Clean carpet starting at the area furthest from the entrance. Spray solution onto the carpet with the carpet wand, using long overlapping strokes followed by 2 or 3 dry passes to extract the liquid & leave the carpet as dry as possible.

When the carpet is completely dry, vacuum to raise the pile.
