HAND WASHING:

$\frac{1}{2}$ (75 ml) per 10 L water - Dissolve powder completely.

CLOTHES CARE:

Always check colourfastness & wash nonfast colours separately.

For flame resistant finishes use only the machine programme for fine fabrics (up to 50°C).
