

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 646 tCO2e by 2029. This is a reduction of 25%.

Carbon Reduction Projects

The following environmental management measures and projects have been completed or implemented since the 2019 baseline. The carbon emission reduction achieved by these schemes equate to 546 tCO2e, a 40% reduction against the 2019 baseline.

- Offices upgraded to include HVAC systems for heating and cooling, LED lighting on motion sensors and full double glazing throughout.
- LED lighting has been installed in 2 of the 4 factory areas.
- Air compressor systems have been addressed for leaks and continue to be monitored on a regular basis.
- Company cars have been swapped from petrol / diesel to plug in hybrid / full electric.
- Environmental Management is controlled under ISO14001 certificate number EMS506072.

In the future we hope to implement further measures such as:

- Complete installation of LED lighting systems for the other 2 units.
- Conduct studies on the production oven and make improvements.
- Optimism voltage on site.
- Investigate solar as a potential source of power.
- Campaign throughout the site for a switch off culture.

Declaration and Sign Off
