## **EXPLOSIVE PRECURSORS ACT - 2023**



In October 2023, the Explosives Precursors Regulation will be updated by the Control of Poisons and Explosives Precursors Regulations 2023 (SI 2023 No. 63). The regulation extends the list of substances included and distinguishes between regulated and reportable substances.

The relevant Evans products and the reason for their inclusion are listed below.

## **Regulated Substances**

The sale of regulated substances is restricted to businesses and members of the public who hold a Home Office Explosives Precursors and Poisons (EPP) licence. There are additional restricted substances and new requirements to verify the legitimacy of the business user or professional. Businesses should ensure that staff are aware of the products covered and the obligations and offences that apply.

The following is required for any sale of a regulated substance:

Photographic proof of identity.

Company name, address and VAT number.

Statement of the intended business use or public function.

There is a requirement for businesses to keep records, suitable for inspection, for 18 months and to get a signature for each consignment.

## **Reportable Substances**

Reportable substances can be supplied to the general public, but there is an obligation to report suspicious transactions (or attempted transactions).
